# Statement on Accreditation



Forge Theological Seminary (FTS) is not accredited by any accreditation agency recognized by the United States Department of Education (USDE) or the Council for Higher Education Accreditation (CHEA). That does not mean, however, that the educational programs offered by FTS are inferior to those institutions that have chosen either regional or national accreditation. According to the USDE,

Unaccredited institutions are not reviewed against a set of standards to determine the quality of their education and training. This does not necessarily mean that an unaccredited institution is of poor quality, but earning a degree from an unaccredited institution may create problems for students.[1]

Two qualifications must be made regarding the above statement by the USDE. First, while it is true that unaccredited institutions are not reviewed by USDE/CHEA accreditors, such institutions may be reviewed against another set of standards. In the case of FTS, the quality of our academics and degree programs is ensured by godly persons who possess a commitment to biblical fidelity and who are aware of what constitutes rigorous and effective curricula. The assumption in the USDE's statement is that an education from an institution accredited by a USDE/CHEA recognized accreditor is necessarily of good quality. In light of the ungodly and unbiblical education offered by a legion of traditionally accredited institutions, this assumption is invalid. Second, whether a degree from an unaccredited institution will create problems for a graduate is dependent upon what one intends to accomplish with an unaccredited degree. Degrees obtained from FTS are intended only for service to Christ's church, whether in the pulpit, on the mission field, or in other ministerial vocations. If a student intends to achieve a career in academia or another vocation that requires education from an institution with traditional accreditation, he or she ought to attend another institution.

Achieving regional or national accreditation is an expensive and lengthy process that requires an institution to meet a variety of criteria that may or may not be in the best interest of either the institution or its students. While there are several excellent national Christian accreditors (e.g., Transnational Association of Christian Colleges and Schools, or the Association for Biblical Higher Education), even these require a certain amount of involvement with the federal government.

# Statement on Accreditation Cont.



For instance, Title IV compliance is required by both the aforementioned accreditors. FTS has opted to refrain from such involvement with the federal government to maximize our religious and academic freedom. Moreover, given the recent trajectory of government-recognized accreditors in light of the Employment Non-Discrimination Act (ENDA), we believe it is unwise to yoke FTS with the government in any manner.

We believe the local church should not be concerned about secular or parachurch accreditation for theological education and pastoral formation. The church has its own authority from King Jesus. It doesn't ultimately submit to the state for theological education. Further, the church doesn't submit to colleges, seminaries, universities, accrediting agencies, or parachurch organizations. Because of these convictions, the leadership of Forge Theological Seminary has not sought accreditation with any accrediting institution affiliated with the federal government.

# Degree Programs



## Undergraduate Studies

### **Associate of Theology (Theology)**

The Th.A. program is designed to give basic training in biblical and theological studies.

At 60 credit hours, students generally complete this program in two years of full-time study.

Associate of Theology (Biblical Counseling)  
The Th.A. program

### **Bachelor of Theology (Theology; Degree Completion Program)**

This program is designed for students who want a thorough knowledge of the Bible and theological studies for training as preparation for ministry and for graduate study. The Th.B. in theology is a degree completion program designed for students who possess some college or an Associate degree. Graduation requires a total of 120 credit hours or the equivalent of four years of full-time study.

### **Bachelor of Theology (Biblical Counseling)**

*This program is forthcoming.* This program provides students with a thorough knowledge of biblical and theological studies and biblical counseling.

## Graduate & Doctoral Studies

### **Master of Theology (Biblical & Theological Studies)**

The M.Th. in Biblical and Theological Studies is designed for students who want advanced knowledge of the Bible and systematic theology ideally for training as preparation for ministry or doctoral education. The M.Th. is a 36 credit hour program that is generally completed in one year of full-time study.

### **Master of Theology (Research)**

The M.Th. (Research) affords students the opportunity to conduct rigorous research in one of six areas. Students produce a thesis and undergo a research examination and defense. This program is generally completed in one year of full-time study.

### **Master of Theological Studies (Biblical Counseling)**

The M.T.S. is a 36 credit hour program that equips students with a foundation of Systematic theology and robust training in biblical counseling. This program is designed to equip students for vocational ministry in Biblical Counseling.

### **Doctor of Theology**

Th.D. students will conduct considerable research, produce a dissertation, and undergo a research examination and defense. This is a research-only program that is generally completed in two to four years.

- A graduate degree in Biblical or theological studies or a closely related field (e.g., religion, counseling, ministry)
- Demonstration of proficiency in Biblical Greek (for New Testament concentration)
- Demonstration of proficiency in Biblical Hebrew (for Old Testament concentration)
- Membership in a local church
- General agreement with FTS' doctrinal stance

\*In certain cases students may be able to gain entrance into either the Th.B. (Theology track only), M.Th. (excluding the research track), or M.T.S. programs without the aforementioned educational prerequisites. Students who wish to gain entrance by exception should note this on their application.

# Tuition & Fees



## Introduction

For the first seven years of its operation, Forge Theological Seminary functioned exclusively upon donations and a volunteer faculty. By 2022, it became apparent that the tuition-free model was no longer sustainable. Under the direction of a new provost, Dr. Michael Burgos, the seminary adopted a low-cost subscription-based model that both maintains the accessibility of our programs while ensuring our institution's financial stability. In turn, vast improvements to our online learning platform, web presence, and additions to our faculty have resulted.

## Tuition FAQ

- **Is there an application fee?** No, applying to Forge Theological Seminary is completely free.
- **When do I pay?** Students who have already completed the application process are eligible to begin their subscriptions.
- **How do I pay?** Using the links provided on our tuition page, select your program and initiate your monthly subscription.
- **Will my tuition increase?** We guarantee no tuition increases for students who are presently subscribed to a monthly payment plan.
- **Is there another method of payment?** Because we have sought to keep our tuition costs as affordable as possible, there is no other method of payment.
- **What if I miss a payment?** Students who miss one payment are placed on probationary status for a period of one month. We will attempt to draft your account an additional time to cover the missed payment. Students who miss two payments will be removed from their program until payment is made. Additionally, students who have missed payments will be unable to obtain copies of their transcript until overdue balances are paid in full.
- **I do not wish to continue in my program. How do I end my subscription?** End your subscription through your PayPal account. Contact [info@forge.education](mailto:info@forge.education) to end enrollment.
- **May I pause my program?** Programs may be paused only when you are not presently enrolled in a course. Students who are between courses may contact [info@forge.education](mailto:info@forge.education) and explain their desire to pause studies. Cancel your subscription through your PayPal account. Students who wish to withdraw from a course should contact our office via email.
